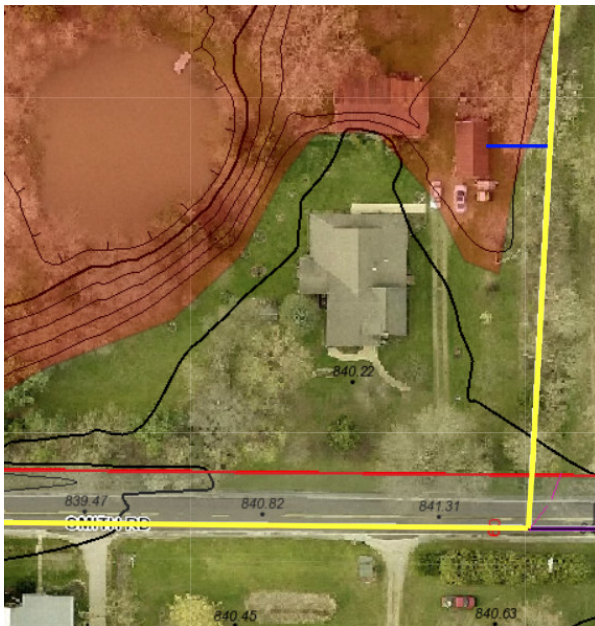
- 8-18 Received a call from Heather from Clayton Homes. Requesting status of permit. Required Information: fee.
